FINAL SHOW CAUSE NOTICE U/S17

WHEREAS, Recognition was granted to the institution namely Andhra Muslim College of Education, D.No.17-11-24, Ponnur Road, Guntur-522003, Andhra Pradesh run by Mohammadiya Education Society, Guntur-522003, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2007-2008/8724 dt. 23:08.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students. (two units) from the academic session 2015-2016.
- 3: AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on 21.02.2019. The institution has submitted a letter dated 28.02.2019 in response to the Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply of Show Cause Notice submitted by the institution on 28.02.2020 and the request of institution for reduction of intake from 2 units to 1 unit in B.Ed course is accepted. Further, the Committee decided that the institution be issued a Final Show Cause Notice for submission of documents required to ensure the adherence of conditions stipulated under NCTE Regulations, 2014 within 21 days from the date of issue of Final Show Cause Notice for submission of following documents:

The institution is required to submit a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)

The institution is required to submit a copy of Land Use Certificate. The
institution is required to submit an attested/notarised copy of Land Use
Certificate issued by the Competent Authority.

In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.

It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.

Your reply, complete in all respects must reach this office within 21 days of the issue of this Final Show Cause Notice.
